These lists, with their quaint but vivid descriptions, particularly of cattle, were taken directly from "Record of Married Women's Separate Property in the County of Baker, State of Oregon", while what is now the ghost town of Auburn was still the county seat. The little record book, much of it in the handwriting of Samuel A. Clarke, the first county clerk of Baker County and later a well known historian and poet, is preserved in the basement vaults of the Baker County court house.

Such a separate inventory of women's property has not been found in any other court house in Oregon. It is interesting as showing that in the early 60's, at least in the freer environment of a gold mining region, women had considerable rights of their own. The nature of the property, not at all predominantly of household goods and other feminine possessions, is also interesting. Mining claims, store buildings, horses and oxen are described with minute exactness, recreating in vivid detail these long vanished ghosts of possessions.

Commencing at the South East corner of Said lot thence South along the line of Said lot upon the Street for the distance of Twenty Five feet (25 feet) thence West fifty feet (50 ft) thence South Twenty-five feet (25 ft) thence East fifty feet to the place of beginning.

The same being my separate property and having come to my possession by devise.

Lot No. three (3) in block (E) in Lower Auburn Baker County State of Oregon. Also the following personal property to wit, Sixteen (16) head of Work oxen and fifteen cows,

described as follows to wit, One yoke of red steers, one dark brindle point of left horn off, One blu speckled Steer one yoke of Mexican Cattle, one a dark brown the other a black and white pided. One yoke one a red sided white back and short tail, the other a red spotted roan steer. One yoke of small red cattle, one white back and some white in face; One yoke of spotted brindle and roan steers, one yoke of red and roan pided steers, one yoke of red white faced steers: also one red cow white mottly face small horns, one horn broken; One dark red cow small horns; one red cow; two large red cows; one speckled roan muley cow; one red roan cow small horns; one small white cow; one small white and red speckled cow, broken horn; One red cow small white star in forehead; one red and white pided cow.

One dark roan spotted cow. One white cow ends of horns Sawed of;
One Small red cow, one horn slightly droop; One Small red cow; All of
which is branded on the horns with the letter (S)-- I propose to use in
the business of teaming and the dairy business and all the proceeds thereof
I do claim as my own Separate property as all has been bought with My own
money, and I propose to carry on the Said business in my own name and right.
